Meanwhile, in terms of terminology, studies with the theme interconnection mean that the term is the relationship between various scientific disciplines, where interconnection requires intersections between certain scientific fields.(Rohman, 2017). A similar definition was also expressed by Abdurrahman Assegaf that interconnection is the connection of one knowledge to another because there is a relationship that influences each other. According to KBBI, Interconnection is a relationship with each other. Interconnection is also an effort to understand the life that humans live, so that all scientific buildings can collaborate, mutually correct, complement, and connect between scientific disciplines.(Mufid, 2013). Studies with the themeinterconnection, have the following characteristics: linking and correlating two or more different scientific disciplines, as well as understanding and analyzing various increasingly complex problems faced by humans(Sugilar, 2019).

Study of Interconnections are divided into several types, kinds and certain patterns according to the categories used. Theme classification Interconnection is

divided into 2 types, namely Islamic sciences and general sciences(Al-Madani, 2020). Religion

The study of Religion has an etymology, terminology and certain characteristics. As for etymology, the study with the theme Religion is that the word Religion comes from the Latin "religio", which means Obligation/obligation (Yusron Masduki, 2020). However, there are also those who argue that religion comes from the Sanskrit "a" which means not and "gam" which means chaotic, so not chaotic (Kurniawan, 2017). Theme classificationReligion is divided intotwo types, namelycelestial religion and ardhi religion. Celestial religion is a religion that comes down from the sky based on God's revelation. Divine religion was revealed to the apostles who taught it to humans, while Ardhi religion is one that develops based on culture, region, a person's thoughts that are accepted globally, and is not based on revelation. (Fitriani et al., 2023). As forReligion there are four types, namely belief (religious belief), rituals and ceremonies (religious ritual), personal experience (religious experience) and moral community (religious community)(Mawardi, 2016). Meanwhile, in terms ofReligion, there arefive patterns, namelyReligion of dynamism (belief in mysterious supernatural powers), animism (belief in every animate and inanimate object having a spirit), polytheism

(belief in gods -gods), henotheism (belief that one god is for one nation), and monotheistic religion (belief that there is one god) (Blogger, 2014).

Feminism

Feminism(comes from the feminine word inFrench) is aadjectivewhich means "femininity" or to show characterWoman. Feminism is a flow of women's movement that fights for women's rights. Feminism is a seriessocial movement, political movement, Andideologywhich has the aim of fighting for women's rights by establishing equality in the political, economic, personal and social aspects of the two sexes. Feminism incorporates the position that society prioritizes men's viewpoints and that women are treated unfairly within that society.^[7]Efforts to change it include fightinggender stereotypesand strive to build educational and professional opportunities equal to those of men.s

Study ofFeminism has an etymology, terminology and certain characteristics. As for etymology, the study with the theme Feminism is that the word Feminism comes from English, Racism, which means attacks on attitudes, tendencies, statements and actions that favor a group, especially racial identity. In the KBBI, feminism is prejudice based on national descent, biased treatment towards different ethnic groups or nations. Meanwhile, in terms of terminology, studies with the theme Feminism that This term is an emphasis on race or racial considerations. Race can also benefit those who have more power and privilege than others(Schaefer, 2012). Study with the theme Feminism has the following characteristics: First, it believes that humans are naturally divided, visible from physical characteristics, blood differences and agrees that there is a difference between "pure blood" and "mixed blood." Second, assume that a person's mental condition is closely tied to the condition of their physical structure. Third, a person's personality and capacity for ideas in cultural matters.(Downing, J., & Husband, 2005).

In this section, the 10 articles in the table above will be presented. The first table contains forms of interconnection between religion and feminism. Article 1) contains about Feminism, which is a school of thought that developed almost simultaneously throughout the world(Retnani, 2017). Article 2) contains prostitution as part of a subsystem in a social system that is necessary in society. From the perspective of feminism, women are always not equal to men and receive discrimination from the social system(Hannam, 2013). Article 3) contains the impact of Marxist feminist thought and the culture in Indonesia on children's education(Saiddaeni S, 2023). Article 4) contains about feminism, which is a civilizational trend that leads to equality in all areas of life, without discrimination because of gender differences.(Abbas, 2020). Article 5) contains the women's movement in Indonesia in the early stages which was more directed towards efforts to advance women's education, involve women in political activities, and as an effort to fight Dutch and Japanese colonialism with national awareness to unite and achieve true independence. (Aliyah et al., 2018). Article 6) contains about Islam playing a more active role in overcoming the problems faced by Muslim women(Izziyana, 2017). Article 7) contains about Islamic Feminism which is a correction to the secular concept of Western feminism(Prodi et al., nd). Article 8) contains feminist interpretations using the Koran as a source of authority to uphold justice and gender equality(Zulaiha, 2016). Article 9) contains the topic that religion has a complex role in relations between men and women(Haryati, 2017). Article 10) contains Deconstructing Women's Inferiority This abstract introduces the concept of religious feminism, a framework that challenges traditional interpretations of religion and promotes gender equality(Alfinnas & Rahayu, 2019).

The data consists of 3 things, namely the form interconnection of religion and feminism (1) separate interconnection (2) connected interconnection (3) included interconnection. These forms include First, separate interconnection sees religion and feminism as two separate entities with no connection. Religion is considered a private matter, while feminism is considered a social movement for gender equality (Example: Article 1 and Article 2). Second, connected interconnection recognizes the relationship between religion and feminism with different scopes. Religion covers spiritual, moral and social aspects, while feminism concentrates on gender equality (Example: Article 3 to Article 5). Third, interconnection includes seeing religion and feminism as complementary. The interconnection between religion and feminism can be a force that encourages gender equality and justice for women. Third, the positive implications the interconnection of religion and feminism onpeople's lives are 3 things: (1) Increasing public awareness about gender equality (2) Developing policies and programs that support gender equality (3) Creating space for dialogue and cooperation between religion and feminism.

This article can be reflected in 3 things: First, various forms The interconnection of religion and feminism shows that the forms are not single, but are very varied, thus refuting the existence of only one finding regarding this form. Second, the various factors that influence the emergence of this form The interconnection of religion and feminism shows that the factors are not single, but are very diverse, both internal and external, thus strengthening the existence of factors in forming this matter. Third, various implications The interconnection of religion and feminism shows that the impact is not only negative, but also has a positive impact.

This article can be interpreted into 3 things: First, there is a form the implied meaning is that It turns out that interconnection is not always disconnected but sometimes it is also connected, even one day the thing that has been disconnected can become a complete part. Religion and Feminism do not always have similarities but have differences. Second, there are factors that influence the birth The interconnection of religion and feminism implies that there are dominant factors that influence the relationship between the two which can determine whether the relationship is separate, connected or included in it. However, there are also factors that are not dominant so they do not influence the relationship between the two. Third, the implication the implied meaning is that This interpretation can be subjective, but based on the data above it shows closeness to something objective. The implications of Interconnection have shown that something must have an impact on other things. This impact can be positive and beneficial for other parties so that they can choose a very good party for now.

This article can have positive and negative impacts. The positive impact is divided into 3 things: First, Urgencynamely the importance of the interconnection of religion and racism which can help distrust and tension between different groups with a deeper understanding of beliefs, traditions and so on. Second, Perspectivenamely expanding views and insights about the interconnection of religion and feminism which helps the complexity of intercultural relations in an increasingly globally connected society. The difference is, the article only emphasizes negative implications, whereas this article discusses 3 positive implications

This article can be followed up with actions related to the themes above in 3 ways: first, countering issues, namely looking for comparable issues to balance feminist thinking. Second, internalize ethical and moral values to fortify society. Third, spreading outreach to the wider community about feminism

This article can be followed up with actions related to the themes above into 3 things: First, education and awareness. By holding seminars, workshops or public lectures aimed at increasing understanding of various religions and cultures in society. As well as forming inter-religious discussion groups at the community level or educational environment to promote positive dialogue and break down negative prejudices. Second, Advocacy (defending), Supporting laws and policies that protect individual rights regardless of religion or race. Also, join a nongovernmental organization or social movement that focuses on fighting racial and religious discrimination. Third, educational campaigns, Create social media campaigns (actions) or public awareness campaigns that emphasize messages of peace, harmony and tolerance between religions and races. As well as, creating educational programs in schools that encourage children to learn about various religions and cultures and understand the importance of respecting differences. This action aims to reduce tension and conflict that may arise due to the interconnection of religion and feminism.

F. Conclusion

The most important finding in this paper is the various forms Interconnection of Religion with Feminism, various factors that influence Interconnection of Religion with Feminism, both internally and externally, as well as supporting and inhibiting, such as the existence of politics and power political leaders exploit religious and racial differences to strengthen their political base in order to create polarization. As well as the varied implications The Interconnection of Religion and Feminism, such as the growing sense of tolerance, the creation of a moderate society, and the emergence of high solidarity, but can also cause negative impacts such as discrimination due to different racial backgrounds, shows that this provides views and insights new about the relationship between religion and feminism. By looking at this relationship, it is an effort to understand religion with various racial differences. The results of the study of the Interconnection of Religion and Feminism will help to grow mutual understanding between various understandings and appreciation of the very diverse diversity in the real life of religious communities at the local, regional, national and international levels.

This paper can make contributions both theoretically, methodologically and practically. In this article, it is also analyzed and interpreted from the author's perspective. Therefore, it is necessary to research various things related to the Interconnection of Religion and Feminism in an effort to develop the study of the Sociology of Religion. It is hoped that further research can develop this material more widely so that it can contribute to research related to forms of interconnection between religion and feminism, influencing factors, and their implications.
